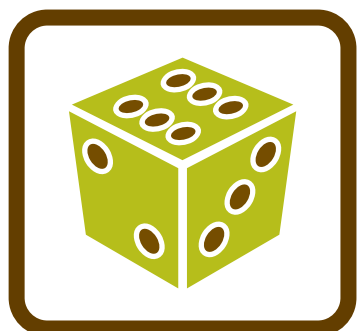

This Act further emphasises the importance of demonstrating Duty of Care and compliance with legislation.

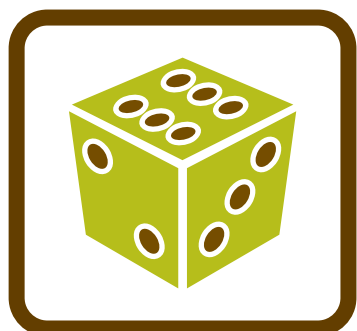

TRIS will automatically send alerts to the person(s) in your organisation who is responsible for coordinating the response to travellers, should an incident or threat be identified that matches a traveller profile. It provides a centralised and consolidated resource of managed information and provides Travel Managers with the tools to make more informed decisions about travel to a particular destination or area.

If you feel that your organisation may benefit from a more detailed risk intelligence system, with statistics which determine threat levels of a destination and monitor when and where your staff are travelling, you may choose to combine TRIS with the Employee Travel Monitoring System (ETMS).

Employee Travel Monitoring System (ETMS)

ETMS is designed for rapid reaction to emerging and active security threats worldwide. The system simultaneously compiles incident and communication event logs, through the use of sophisticated alerting and communication tools.

The way ETMS works is by picking up employees travel itineraries automatically through Key Travel's booking system when an employee makes a reservation. ETMS then monitors our booking system in real-time, displaying employees travel details alongside security and risk information. A threat level indicator from 1 to 5 (5 being the highest) will display in the booking record and it is up to each organisation to decide what they deem to be an acceptable level of risk and therefore whether a planned trip falls within their travel policy.

Importantly, ETMS will send alerts to your travel manager should a critical event be picked up that matches the itinerary of a travelling employee and then provides a suite of communication tools that enables the organisation to coordinate the response to multiple travellers.

Key Features of ETMS:

- Consolidates reservations globally from the Key Travel booking system
- Allows instant location of in-country travellers with the added benefit of detailing travellers en route and due to depart in the coming hours, days and months
- Automatic sending of e-mail notifications and custom emails as per your organisations travel policy
- Tracks employees on any specific flight, train or vessel
- Monitors pre-trip (for passengers travelling in the next 12, 24 or 48 hours), en route and mid-trip travel patterns
- Allows immediate reaction to developing situations and threats
- Allows instant traveller location and contact information
- In the event of an incident, the ETMS provides a detailed event log that can be interrogated and used to show that duty of care obligations were complied with

ETMS holds the traveller's hotel and emergency contact details, in addition to personnel and next of kin information. This information is available in a central, accessible resource which enables corporations to take action in any situation, fast.
